

Frequently Asked Questions

What are the increments you rent in?

We generally rent in 4 hour, 1 day, 3 day, and week long increments, with one day including 8 machine hours. Certain equipment may not have increments less than a day available.

Do you rent trailers?

We rent open, enclosed, flatbed and tilt trailers with pintle hitches. We are not a U-Haul center.

Where can I find a price sheet for your rental items?

The most accurate and up-to-date prices can be found by searching the item on our website.

Can you repair my equipment?

Depending on the item, we can certainly try. Under our sister business 319 Golf Carts, we repair tools like chainsaws and leaf blowers, up to lawn mowers and even golf carts. If you'd like to ask about your specific item, feel free to call us. If you need something picked up or dropped off, then the same round-trip charges apply.

Do you sell equipment?

We do not currently sell, only rent, but occasionally items will go on sale.

How does the weekend special work?

Our popular weekend special allows you to rent equipment from Friday to Monday for the price of one day, granting you 8 hours of machine time. If that item has not been rented or reserved by Friday, you can come in to get it as soon as we open at 8 AM. The weekend special is first come, first serve, and cannot be reserved. If you don't want to gamble on that piece of equipment being available for the weekend special, you can always reserve it for the weekend at the normal rate.

Feel free to call ahead Thursday to see if what you're looking for is planned to be out.

What if I need to keep a piece of equipment for longer?

If you need to keep equipment longer than originally reserved, please call us and see if your rental can be extended.

Do you deliver?

Yes, we deliver any of our equipment for round trip fees depending on the distance traveled.

Can I use your equipment on or in water?

No, water can seriously damage the equipment, salt especially.

Can I transport light equipment myself?

Yes, if you have the appropriate means. Small tools or hand wheeled items can be transported in a properly sized vehicle, larger items can be trailered if suitably secured, tow behind equipment requires an adequate hitch, and riding lawn mowers can loaded onto a trailer with proper loading means.

Can I transport heavy equipment myself?

If you have commercial insurance and can obtain a certificate of insurance, you can tow using one of our rented trailers or your own if it is capable of safely doing so.

What are your requirements for a certificate of insurance?

When speaking to your insurance company, please request that the certificate contains the following:

1. The name and address of the insured customer (you).
2. Crawfordville rentals, LLC, 2273 Crawfordville HWY, Crawfordville FL, 32327 must be listed as the certificate holder.
3. Crawfordville rentals, LLC must be listed as additional insured and loss payee.
4. Proof of general liability of \$300,000 minimum.
5. Proof of physical damage equipment coverage.
6. Policy number for contractor's equipment coverage, and effective/expiration dates of coverage.
7. Rented equipment coverage must be equal to or greater than the value of the equipment rented.
